OUR FLAGSHIP PROGRAM, THE YOUTH SUMMER DAY CAMP, WAS CANCELLED LAST YEAR, HOWEVER, WE DID OFFER A SMALLER CAMP EXPERIENCE AT THE WELLSPRING FACILITY TO 10 CHILDREN. AT CAMP LIFT-OFF, WE PROVIDED EDUCATIONAL AND RECREATIONAL ENRICHMENTS TO YOUTH.

THE AFTER SCHOOL PROGRAM SERVED 84 CHILDREN IN 2020 FOR 102 DAYS OF PROGRAMMING. THEY WERE SERVED FIVE FULL MEALS AND SNACKS EVERY DAY AS WELL AS TRANSPORTATION.
